The Fund is provided by HSBC Global Asset Management Limited (HGAM) which are accessed via a Trustee Investment Plan provided by HSBC Life (UK) Limited. The Trustee Investment Plan is an investment wrapper used within the HSBC Flexible Retirement Account. The Investments held within the HSBC Flexible Retirement Account will be made via the Trustee Investment Plan. The HSBC Global Sustainable Multi Asset Dynamic Fund invests 100% in the HSBC Global Sustainable Multi Asset Dynamic Portfolio. The fund mirrors the objective used by the portfolio and associated investment allocations which are both described below. All investment decisions are made by HSBC Global Asset Management Limited.

#### **Fund objective**

To provide capital growth through investment in assets that meet sustainable investment principles. The Fund invests in a range of sustainable investment strategies which aim to consider financial returns alongside environmental, social and governance factors.
