

# HSBC World Selection Balanced Fund

The Fund is provided by HSBC Global Asset Management Limited (HGAM) which are accessed via a Trustee Investment Plan provided by HSBC Life (UK) Limited. The Trustee Investment Plan is an investment wrapper used within the HSBC Flexible Retirement Account. The Investments held within the HSBC Flexible Retirement Account will be made via the Trustee Investment Plan. The HSBC World Selection Balanced Fund invests 100% in the HSBC World Selection Balanced Portfolio. The fund mirrors the objective used by the portfolio and associated investment allocations which are both described below. All investment decisions are made by HSBC Global Asset Management Limited.

#### **Fund objective**

The Portfolio aims to provide capital growth through balanced investment in a broad range of asset classes across global markets. The Portfolio will invest primarily in collective investment schemes that in turn invest in fixed income securities, equities, property and derivatives.
