

HSBC Global Money Current Account Offer October 2023

Terms and Conditions

Open and use selected HSBC current accounts and a HSBC Global Money Account and get up to £205 and entry into the 24 for 2024 Cash Prize Draw

- Apply for an HSBC Premier or HSBC Advance bank account (each an 'eligible account') on or after **23 October 2023** and before the offer closes or is withdrawn (view General terms section on page 3), and subsequently open that account.
